



### Executive Board Member replacement

- Prof. Hongbing Shen IANPHI Executive Board Member from 2023 to 2025 (China CDC)
- Replacement of Prof. Shen by Prof. Jianwei Wang as Director of the Chinese Center for Disease Control and Prevention (China CDC)
- IANPHI Statutes article 10.2 « If an Executive Board member leaves his/her position at his/her Institute before the end of his/her term as member of the Executive Board, he/she will be allowed to serve until the end of his/her 3-year term on the board without being authorized to be re-elected, provided that his new activities or appointments are not in conflict with the Association's purpose"
- IANPHI Statutes article 10.7 « "If for any reason a member of the Executive Board shall cease to hold office as such at any time between meetings of the General Assembly, the Executive Board is entitled to nominate a new member of its choice as replacement for the rest of his or her terms of office. The General Assembly will have to ratify the appointment of the new member at its following meeting".
- Proposal, as approved by the Executive Board Members on April 3, 2025: to nominate Prof.
  Jianwei Wang as Executive Board Member for the remainder of Prof. Hongbing Shen's mandate

  - Standardization of heat health metrics for a better estimation of the health impacts of extreme heat

Social and Public Health Inequalities Thematic Committee workshop – funded by the International Health Grants Program (PHAC) – Paris, June 10-13, 2025


- How can NPHIs advance equity approaches to well-being to influence population health outcomes?

## International Health Grants Programme of Canada – PHAC 3 ongoing projects

- 1. Building IANPHI Regional Networks & Thematic Committees to Strengthen Public Health Systems, Capacity Building and Resilience
  - No-cost extension approved project end in March 2026
  - Reallocation of budget approved, in particular to support travel and accommodation to the IANPHI Annual Meeting in Maputo (CPLP countries and Latam countries), the Asia Regional Network, Committees' publication and design of reports, Project Coordinator's time
- 2. Building Bridges to Resilience: Iodentifying Good-Practice Principles in Applying Health promotion to Emergency Preparedness & Response
  - Project Lead: Public Health Wales in collaboration with the Univ of Galway (survey to be sent to members soon to collect grey literature)
- 3. How NPHIs can advance equity approaches to influence population's health outcomes
  - Workshop in June 2025 (see previous slide)



## Joint IANPHI-WHO meeting – Expert consultation fo developing key technical resources on EPHFs as part of IHGP-funded projects to WHO & IANPHI

#### Two projects funded by IHGP Canada and led by the WHO

- Project 1: Measuring the integrated delivery of public health functions including health promotion in emergency preparedness and response
- Project 2: Transforming health systems with the essential public health functions for addressing 21st century public health challenges


## Joint IANPHI-WHO meeting – Expert consultation fo developing key technical resources on EPHFs as part of IHGP PHAC funded projects to WHO & IANPHI

#### Meeting end of June/early July 2025, Paris, SpFrance

- IANPHI / NPHI leaders to provide expert review of findings from global evidence collated and synthesized by WHO (participants from IANPHI Member institutes, WHO HQ, Regional Offices as in May 2023)
- Align next steps between WHO-led and IANPHI-led projects funded by IHGP
- Scope for further collaboration between WHO and IANPHI in the delivery of GPW14 output 3.1.2

Deliverables: Scope of potential joint implementation under GPW14, expert feedback to inform finalization of the below technical resources:

- Review of health systems/security monitoring tools and approaches from a public health perspective
- Re-orienting health systems to EPHFs and public health services

# GHEC Project Strengthening NPHIs role in health emergencies

- Project duration: June 2024 to May 2026
- Work in partnership with the WHO Global Health Emergency Corps (GHEC) on the role of NPHIs in enabling rapid response mechanisms in prevention, preparedness and response to health emergencies.
- Objectives:
- A survey of the IANPHI membership and a series of interviews to understand and provide key evidence to enable the GHEC as well as the WHO Health Emergencies Programme to develop a targeted approach for NPHIs' health emergency preparedness and response functions.
- Interviews of 16 members were realised to explore the concept of **connected leadership** from a country, regional and global perspective are still on-going.
- The survey was sent to all IANPHI Members is currently under analysis (60 members out of the 127 IANHI Members participated to the survey).
- > Some of the early findings from the survey to be presented at the afternoon session on Thursday, April 10.
